MEMORANDUM OF ASSOCIATION OF

SACHEKHAND NANAK DHAM

1. Name of the society The name of the society shall  
SACHEKHAND NANAK DHAM.
2. The registered office of the society shall be situated in the Union Territory of Delhi at present it is at : WZK-12 A, New Mahavir Nagar,  
(Near Tilak Nagar)  
NEW DELHI-110018.
3. AIMS AND OBJECTS :
- a) To advance the precept of one Divine Being as expounded by Mahrag Darshan Das and thereby bring men to great realisation of God and increase and sustain his religious belief.
- b) To provide for the public worship of God by means of gatherings for prayer and religious observances.
- c) To relieve in cases of need any persons who are in conditions of hardships or distress or who are aged or disabled.
- To organize discourses on all religious books and to hold conferences on spiritualism and on other subjects to uplift the morals of the people and to create a sense so that they could close to each other voluntarily in fraternity to help each other in distress and further to evolve a sense of love, affection and compassion among the people.
- e) To ~~provide~~ and maintain regularly a langar i.e. free meal in morning, noon and evening for every human beings irrespective of caste, creed and or any religion to which he belongs.
- f) To provide medical advice and medical facilities to suffering poor persons to aid and to promote their living condition, open hospitals, dispensaries, operations theatres, clinics and to provide medicine free of cost to deserving and needy.
- g) To provide succour for the welfare of the poor people at the time of national and natural calamities and for the maintenance of poor widow, orphans who are unable to maintain themselves.
- h) The establishment and maintenance of homes, hostels, shelters sanitoria or the like for the poor, the infirm ill or convalescent persons the aged, widows, orphans or other destitute or abandoned persons.
- i) To establish educational institution and educate the people in the integration and unity of the country and establish libraries and reading rooms and construction of building there.
- j) all the incomes of the society shall be utilized ~~amongst the members~~ for the promotion of aims and objects of the society.



## RULES AND REGULATIONS OF JACHKHAND NANAK DHAM

The following are the provisions of the rules and regulations of the proposed association :

1. MEMBERSHIP : Any person may participate in the activities provided for by the society but its administration shall be restricted to the members who will constitute the Executive Committee.

Any person can become a member of the Society irrespective of caste, creed or faith.

Any person who regularly participates in the functions of the Society shall be deemed to be an Associate member of the Society. An Associate Member, not less than eighteen years of age, who wishes to be elevated to full membership of the Society may apply to participate in the initiatory rite by Mahraz Darshan Das.

NOTE :- The society has been constituted as desired by Mahraz Darshan Das, WZK-12 A, New Mahavir Nagar, New Delhi-110018, the Founder/Patron shall be the Supreme authority of the society. The Founder/Patron shall nominate an executive committee for the management of the society for and on behalf of the founder. The Founder will be the President of the Executive Committee.

2. SUBSCRIPTIONS : Admission fee Rs. 10/- at the time of admission Subscription fee Rs. 10/- per month.

3. TERMINATION OF MEMBERSHIP : The governing body shall have the power to expel a member from the society on the following terms or events;

- (a) On his/her death.
- (b) Non payment of subscription continuous for more than three months.
- (c) On his/her written resignation.
- (d) If he/she has not attended three consecutive meetings of the general body without any intimation.
- (e) If the activities of any member are anti-national anti-social or harmful and prejudicial to the interest of the society or the same are not in accordance with the teachings of Mahraz jee, he may be removed.

4. APPEALS : All the appeals should be preferred to the governing body of the society, the decision of governing body shall be communicated to the person concerned.

5. RE-ADMISSION : The member expelled by the governing body can be re-admitted provided the member concerned pays all upto date dues. The decision of the managing committee shall be final.

6. GOVERNING BODY : It shall consist of all members of the society. *There shall be a Patron of the Society.*

7. BANK ACCOUNT : The bank account of the society shall be operated by the President and cashier/Accountant.

8. FUNCTION OF THE GENERAL BODY :

- (a) To consider any business brought forward by the governing body.
- (b) There shall be an annual meeting of the general body in the month of March year.
- (c) Not less than 15 days notice shall be given to the members before the date of general body meeting, enclosing the agenda specifying date, time and place.

9. SOURCES OF INCOME :

- (a) Admission Fee
- (b) Subscriptions
- (c) Donations and special contributions.

10. MANAGING COMMITTEE :

There shall be a Patron of the society who shall be the Supreme authority in the Society. Mahraz Darshan Das, the founder of Sachkhan Nanak Dham, is the first life time Patron of the society.

On falling vacant Mahraz Darshan Das's successor will be appointed the Patron of the society in the presence of congregation at a special inauguration satsang.

The management of the society shall be entrusted to the Executive Committee of not less than five and shall hold office for one year. The meetings of the governing body shall be held as and when necessary for which ten days notice will be required and the quorum shall be 2/3rd.

11. ELECTION AND QUORUM : The general body in its annual meeting will elect its President and all the office bearers and members in the month of March after one year by secret ballot papers the general body and shall be 2/3rd.

12. FUNCTION OF THE GOVERNING BODY :

- a) To arrange, finance if required from other Bank(s) Institutions or individuals or reasonable terms and conditions and governing body as a whole is liable for its return.

- b) The governing body shall make plan for the future programme of the society.
- c) To appoint, terminate and fix duties of any staff.
- d) The governing body shall sit at least in a month.
- e) To publish literature to propagate the system and to approach the public for the uplift the status of the society.
- f) To accept donations, charities, loans, grant, properties etc. from public, other associations, agencies, Government Department in the interest of the promotion or the aims and objects of the society.

13. MANAGING OF FUNDS : All the incomes of the society shall be deposited in a nationalised bank.

14. POWER AND DUTIES OF OFFICE BEARERS :

PRESIDENT

He will be the head of the society and preside over meetings of the general and governing body. He will have the right of casting vote in case of societies.

VICE-PRESIDENT

In the absence of President, the Vice President will enjoy all the powers which are entrusted to the President.

GENERAL SECRETARY

The powers of the General Secretary are as under :-

- a) To sign on behalf of the society and to conduct its correspondence and to record the proceedings of such meetings.
- b) To summon and attend the general meeting of the general body.
- c) To call ordinary general meeting if desired on written request of at least twenty members.

SECRETARY

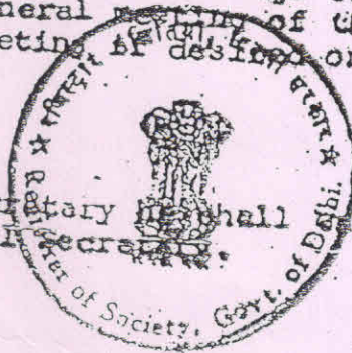
In the absence of the General Secretary, all powers which are entrusted to the General Secretary.

ASSISTANT SECRETARY

He will assist the Secretary.

CASHIER-CUM-ACCOUNTANT

He will maintain proper accounts of the society and shall keep Rs. 200/- with him and the balance amount will have to be deposited in any scheduled Bank.





15. AUDIT

The accounts of the society shall be audited at least once a year by an auditor appointed by the general body.

16. FINANCIAL YEAR : The financial year of the society shall start from 1st April to 31st March every year.

17. TENURE :

The term of governing body shall be one year.

18. AMENDMENT :

Alterations, extension or abridgement of propose 'Aims and Objects' or change of name, section 12 and 12 (A) of the S.R. Act of the 1860 as applicable to the Union Territory of Delhi. The amendment in the memorandum shall be made under this section.

19. LEGAL PROCEEDINGS : (Section 6 of the Act)

The society may sue or be sued in the name of the President, General Secretary or Secretary as per provisions laid down under section S.R. Act 1860 as applicable to the Union Territory of Delhi.

20. ANNUAL LIST OF MANAGING GENERAL BODY :

Once in every year a list of the office bearers and members of the governing body shall be filled with the registrar of societies, Delhi as required under section 4 of the societies Registration Act of 1860 as applicable to the Union Territory of Delhi.

21. DISSOLUTION :

If the society need to be dissolved it shall be dissolved as per provisions laid down under section 13 & 14 of S.R. Act of 1860 as applicable to the U.T. of Delhi.

All the provisions under the section of the societies registration Act of 1860, as applicable to the Union Territory of Delhi, shall apply to his society.
